I am aware that if I violate any of these codes and rules, I may be subject to severe disciplinary sanctions as set out in the respective code. Applicable law is Swiss law. Copies of the IDSF ANTI-DOPING CODE and IDSF COMPETITION RULES have been made available to me.

I the undersigned \_\_\_\_\_ (*name of athlete*) accept the STATUTES of the IDSF, in particular the exclusive competence of the Court of Arbitration for Sport in Lausanne, Switzerland, which will resolve definitively the dispute in accordance with the Code of sport-related arbitration. Applicable law is Swiss law.

I also understand that the analysis of my sample might reveal evidence of disease. In such an instance I have the right to be informed, however only on my own request, after a confidential notice by the laboratory. Such information will be in all events remain confidential to the laboratory and myself.
