



Appendix Reimbursement of Expenses (Rule B 5)

The minimum reimbursement of expenses to athletes, competition couples, chairpersons, invigilators and adjudicators for competitions covered by RULE E.4 or for rehearsals according to these Rules will be fixed by the Presidium. Members will be notified of the amounts in advance.

A) CHAIRPERSONS, INVIGILATORS and ADJUDICATORS: (Valid for all competitions covered by Rule E.4)

Travel expenses: 1st class rail fare home-competition-home,

or economy air fare acceptable to the organizer. Full advantage must be taken of

weekend or similar tariffs.

Accommodation: Hotel accommodation with breakfast for

two nights. A lump sum of 250.00 CHF (Adjudicators for all WDSF granted events), 400.00 CHF (Chairperson in Championships and Cups) and CHF 300.00 (Chairperson all events except Championships and Cups) must be paid

in convertible currency.

make payments toward expenses at their discretion. There are special conditions for the WDSF Grand Slam Series published in

advance by WDSF.
